DISCLOSURE TEXT ON THE PROTECTION AND PROCESSING OF VISITOR PERSONAL DATA

Pursuant to the Law No. 6698 on the Protection of Personal Data (hereinafter referred to as the "Law" and/or "KVKK"), your personal data may be processed by QVV Mühendislik Sanayi ve Ticaret Limited Şirketi (hereinafter referred to as the "Company") as the data controller within the scope described below.

a) Purpose for which Personal Data will be Processed

Your personal data collected within the scope of your visit; In order to ensure the legal, technical and commercial-business security of the Company and the relevant persons who have a business relationship with the Company, it may be processed within the personal data processing conditions specified in Articles 5 and 6 of the Law.

b) To whom and for what purpose the processed personal data can be transferred

Your collected personal data may be transferred to legally authorized public institutions and private persons or organizations and third parties within the scope of the realization of the above-mentioned purpose within the framework of the personal data processing conditions and purposes specified in Articles 8 and 9 of the Law.

c) Method and Legal Grounds for Collecting Personal Data

Your personal data is collected by our Company in a physical and/or digital environment in order to ensure security, based on the legitimate interests of our Company; in accordance with the personal data processing conditions specified in Articles 5 and 6 of the Law.

ç) Rights of the Personal Data Owner listed in Article 11 of the Law

As a personal data owner, we inform you that you have the following rights pursuant to Article 11 of the Law:

- Learn whether your personal data is being processed,
- Request information if your personal data has been processed,
- To learn the purpose of processing your personal data and whether they are used in accordance with their purpose,
- To know the third parties to whom your personal data is transferred domestically or abroad,
- To request correction of your personal data in case of incomplete or incorrect processing and to request notification of the transaction made within this scope to third parties to whom your personal data has been transferred,
- Although it has been processed in accordance with the provisions of the Law and other relevant laws, to
 request the deletion or destruction of personal data in the event that the reasons requiring its processing
 disappear and to request notification of the transaction made within this scope to third parties to whom
 your personal data has been transferred,
- To object if a result arises against you by analyzing the processed data exclusively through automated systems,
- To request compensation for damages in case you suffer damage due to unlawful processing of your personal data.

You can submit your applications for your rights listed above to our Company by filling out the Data Owner Application Form, which you can obtain from http://qvv.com.tr/ and/or our Company. Depending on the nature of your request, your applications will be finalized free of charge as soon as possible and within thirty days at the latest; however, if the transaction requires an additional cost, you may be charged a fee according to the tariff to be determined by the Personal Data Protection Board.
